This event is Australia-wide and is conducted by the ABF. It is the only opportunity for players to earn Gold Materpoints in their local club. It works like this:-

- Australia is divided into regions on a Geographical Basis
- Each region provides a set number of teams to the national Final (total 60)
- Clubs hold heats to qualify teams to a final within their region
- NSW Regional Final will be played at NSWBA on September 23<sup>rd</sup> & 24<sup>th</sup>
- The National Final is played on 24<sup>th</sup> November in Tweed Heads

We'll be running a 5- teams qualifying event on Mondays June 5<sup>th</sup> and 12<sup>th</sup> (as well as our normal duplicate bridge sessions)

Prizes are also awarded in restricted divisions of under 25, under 50 and under 100 masterpoints (as at 30<sup>th</sup> June, 2017)

The tenuous connection of the following story is that I overheard it while playing bridge at Double Bay on Tuesday night.



## IT IS THE LAW

It seems timely to quote some of the provisions from the "2017 Laws of Duplicate Bridge" which is up-dated every 10 years under the auspices of the World Bridge Federation.

#### LAW 9 PROCEDURE FOLLOWING AN IRREGULARITY A Drawing attention to an irregularity

- 1. Unless prohibited by Law, any player may draw attention to an irregularity during the auction period, whether or not it is his turn to call
- 2. Unless prohibited by Law, declarer or either defender may draw attention to an irregularity that occurs during the play period.

### B After attention is Drawn to an Irregularity

- 1. (a) The Director should be summoned at once when attention is drawn to an irregularity.
  - (b) Any player, including dummy, may summon the Director after attention has been drawn to an irregularity.
- 2. No player shall take any action until the Director has explained all matters in regard to rectification.

### LAW 10 ASSESSMENT OF RECTIFICATION A Right to Determine Rectification

The Director alone has the right to determine rectification when applicable. Players do not have the right to determine (or waive – see Law 81C5) rectification on their own initiative.

### LAW 81 - THE DIRECTOR

A Official Status

The Director is the official representative of the Tournament Organiser. C Director's Duties and Powers The Director (not the players) has the responsibility for rectifying

irregularities and redressing damage.
